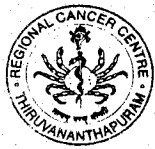

Sealed limited tender is invited in two bid system for the supply, installation and commissioning of **one DENTAL CHAIR** with accessories in the Dental Wing of Regional Cancer Centre, Trivandrum.

The tender should be submitted in two bid systems ie Technical bid and Financial bid separately. Both envelopes should be properly sealed and should bear the superscription " Limited tender No.13/RCC/18:19/P5 & should be addressed to the Director, Regional Cancer Centre, Trivandrum-11.

### The technical bid should contain :

- Detailed technical specification of the product
- Brochure or literature supporting of the technical specification if any
- EMD or EMD Exemption certificate
- List of installations in Kerala state
- Details of service facility in Trivandrum
- Delivery and commissioning period
- Payment condition
- Warranty (Minimum required comprehensive warranty-01 year)

### The financial bid (price bid) should contain

- Price of the Dental Chair
- If GST is extra, % of GST should be clearly mentioned
- Comprehensive maintenance contract amount.

The tenders duly signed and sealed in each page by the tenderer along with necessary documents shall be submitted to the Purchase Officer, Regional Cancer Centre, Trivandrum-11 on or before **4 PM on 17/08/2018 (Friday)**. Late tenders will not be accepted. The tenderer should enclose the EMD amount of Rs.2,000/-by way of Demand draft /Bank Guarantee/ Fixed Deposit in favour of Director, RCC, Trivandrum along with the technical bid which is refundable. Earnest Money Deposit (EMD) is exempted in the following cases. If the tenderer comes in any of the following category, they should submit a self attested copy of the relevant certificate for EMD exemption.

a) Firms who are registered with the Stores Purchase Department or the Directorate General of Supplies and Disposals, New Delhi are exempted from furnishing EMD for tenders in respect of stores by which they have registered as suppliers of stores.

b) Micro and small enterprises and Industrial Co-operatives within the Kerala State which are certified as such by the Director of Industries and Commerce or by the General Manager, District Industries Centre are exempted in respect of certified items from furnishing EMD in support of tenders.

c) The Khadi and Village Industries Co-operative Societies and the Institutions registered under the Travancore Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 within Kerala State which are certified as such by the Secretary, Kerala Khadi and Village Industries Board are exempted from furnishing EMD in support of tenders.

d) Micro, Small & Medium enterprises registered with the National Small Industries Corpora on Limited, New Delhi and in respect of which competency certificates are issued by the Corporation will be exempted from payment of EMD.

e) Government Institutions/Kerala State Public Sector Undertakings which manufacture and supply stores are exempted from furnishing EMD.

f) Kerala State Small Industries Development Corporation on Ltd when it participates in tender on behalf of Small Scale Units will be exempted from furnishing EMD.

The technical bids will be opened at 3 PMon **18/08/2018**

(saturday) in the presence of such of the tenderers or their authorized representatives who may be present at that time. The financial bids of technically qualified firms will be opened after technical evaluation and the date will be intimated to the tenderers.

### **Specification of the Dental Chair and other Accessories**

1. Body contoured fully automatic multi programmable.
2. LED operating light having multisurface glass reflector on/off and intensity control by non-touch sensor with 3 directional movements.
3. Chair side porcelain spittoon with auto water connection.
4. High and low vacuum motorized suction with auto drainage.
5. Should have Airtor points.
6. Should have Micromotor points with digital display of speed.
7. Should have three way syringes.
8. Should have LED X ray viewer
9. Should have instrument tray
10. Multifunction foot control

### **Accessories**

1. Dental operators adjustable stool
2. Air Compressor 1 HP for Dental Chair
3. Airtor hand piece
4. Micromotor hand piece straight and contra angle

### **Terms and conditions:-**

1. The brand new model Dental Chair shall be quoted and supplied.
2. The make and model of the item should be clearly specified
3. The offer should be valid up to 30/12/2018
4. Supply :-Supply should be done in Dental wing of RCC
5. Delivery Period: All items as per the supply order shall be supplied , installed and commissioned in the Dental wing of RCC to their satisfaction within 30 days from the date of order.
6. Penalty: If it is delayed beyond 45 days, RCC will charge a penalty of 0.05% of the total value per day for the first 30 days and thereafter 0.06% per day.
7. Installation: Installation should be done by the supplier free of cost.
8. Warranty: The supplied equipment should have the minimum

comprehensive warranty of one year from the successful commissioning and acceptance by RCC. CMC amount should also be quoted in the financial bid which will be taken for price comparison.

9. Payment:- Payment will be released within a maximum period of 90 days from the date of successful commissioning & certification. RCC has an option to make the payment within 30 days from the date of successful commissioning and final acceptance by RCC, provided 3% of the total bill amount will be deducted. If the tenderer wishes to avail this benefit, that should be mentioned in the offer.
10. The successful tenderer has to submit an agreement in Kerala Stamp paper worth Rs.200 and a security deposit of 5% of the total value of the order within 15 days from the date of receipt of order. This deposit amount will be refunded after the supply & final acceptance by RCC.
11. Director of Regional Cancer Centre, Trivandrum reserves the right to accept or reject all or any tender at his sole discretion without assigning any reasons. For legal purposes, the cause of action will be deemed to have arisen in Trivandrum, Kerala state.
