Oxygen Concentrators

Sir,

Sealed limited tenders are invited in two bid system for the supply, installation and commissioning of Three units of Oxygen Concentrators pay wards and General wards of Regional Cancer Centre, Trivandrum. The tender should be submitted in two bid system ie technical bid and financial bid separately. Both envelopes should be properly sealed and should bear the superscription "Limited tender No.4/RCC/17:18/P3 and should be addressed to the Director, Regional Cancer Centre, Trivandrum 695011. The technical bid should contain

- Detailed technical specification of the Oxygen Concentrator model quoted
- Brochure or literature supporting the technical specification if any
- EMD or EMD exemption certificate
- List of installations in Kerala state
- Details of service facility
- Delivery and commissioning period
- Payment condition
- Warranty

The financial bid (price bid) should contain

- Total Price of the equipment. If VAT is extra, % of VAT should be clearly mentioned

The tenders duly signed and sealed in each page by the tenderer along with necessary documents shall be submitted to the Director, Regional Cancer Centre, Trivandrum -

695011 on or before 2PM on 03/05/2017(Wednesday).Late tenders will not be accepted. The tenderer should enclose the Earnest Money Deposit (EMD) amount of Rs.1500/- by way of Demand draft/Bank Guarantee/Fixed Deposit in favour of Director, RCC, Trivandrum along with the technical bid which is refundable. EMD is exempted in the following cases. If the tenderer comes in any of the following category, they should submit a self-attested copy of the relevant certificate along with the technical bid for EMD exemption.

- a) Firms who are registered with the Stores Purchase Department or the Directorate General of Supplies and Disposals, New Delhi are exempted from furnishing EMD for tenders in respect of stores by which they have registered as suppliers of stores.
- b) Micro and small enterprises and Industrial Co-operatives within the Kerala State which are certified as such by the Director of Industries and Commerce or by the General Manager, District Industries Centre are exempted in respect of certified items from furnishing EMD in support of tenders.
- c) The Khadi and Village Industries Co-operative Societies and the Institutions registered under the Travancore Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 within Kerala State which are certified as such by the Secretary, Kerala Khadi and Village Industries Board are exempted from furnishing EMD in support of tenders.
- d) Micro, Small & Medium enterprises registered with the National Small Industries Corporation Limited, New Delhi and in respect of which competency certificates are issued by the Corporation will be exempted from payment of EMD.
- e) Government Institutions/Kerala State Public Sector Undertakings which manufacture and supply stores are exempted from furnishing EMD.
- f) Kerala State Small Industries Development Corporation Ltd when it participates in tender on behalf of Small Scale Units will be exempted from furnishing EMD.

The technical bids will be opened at 3.00 PM on 04/05/2017 (Thursday) in the presence of such of the tenderers or their authorized representatives who may be present at that time. The financial bids of technically qualified firms will be opened after technical evaluation and the date will be intimated to the technically qualified tenderers.

SPECIFICATIONS

Oxygen Concentrator – 3 Nos

1. Capacity – 5 Ltrs
2. Outlet Pressure – 8.5 – 9.00 psig (58.6 kPa)
3. Oxygen Percentage- 1-10 LPM,93% +/- 3%
4. Weight – 15-17 Kg
5. Power Supply – 220-240 Volt AC,50Hz
6. Alarm – Audible and visual high/low pressure, low flow, low oxygen, power fail, Oxygen sensing device
7. The equipment should be supply with the readily accessible patient control and protected cannula fitting.
8. The equipment should supply with lockable flow meter and humidifier

9. The unit should comply with EN60601-1-2, Class II – B
10. Sound level should be less than 50 dBA
11. Should provide with top and side handle for easy transportation
12. Product demonstration should be done

Terms and conditions:-

1. The brand new model of Oxygen Concentrator shall be quoted and supplied
2. The offer should be valid up to 30/06/2017
3. Commissioning period:- All items as per this order should be commissioned within 30 days from the date of this order.
4. Delivery Place: Oxygen Concentrators shall be delivered and unloaded in the pay ward and General ward of RCC..
5. Installation: Installation should be done by the supplier free of cost
6. Penalty: If it is delayed beyond 30 days, RCC will charge a penalty of 0.05% of the total value per day for the first 30 days and thereafter 0.06% per day.
7. Warranty:- The supplied equipment should have the comprehensive warranty of one year from the date of successful commissioning and acceptance by RCC.
8. Payment (a) Payment will be released within a maximum period of 90 days from the date of successful commissioning & certification. RCC has an option to make the payment within 30 days from the date of successful commissioning and final acceptance by RCC, provided 3% of the total bill amount will be deducted. If the tenderer wishes to avail this benefit, that should be mentioned in the offer.
9. Any attempt on the part of tenderers or their agents to influence the officers concerned in their favour by personal canvassing will disqualify the firm.
10. Companies/Firms who have been/are indulged in illegal bid rigging and cartelization, forged document submission etc during the last 3 years and have been penalized by any government agencies such as Competition Commission of India (CCI), Government of Kerala etc will not be entertained for participating in Tender.
11. If the contract is awarded, they have to submit an agreement in Kerala Stamp paper worth Rs.200 and a security deposit of 5% of the total value of the order within 15 days from the date of receipt of supply order. This deposit amount will be refunded after the expiry of contract successfully.
12. Director of Regional Cancer Centre, Trivandrum reserves the right to accept or reject all or any tender at his sole discretion without assigning any reasons. For legal purposes, the cause of action will be deemed to have arisen in Trivandrum, Kerala state.
