

TENDER-CUM-AUCTION NOTICE

Sub: Disposal and removal of Garbage Item at RCC by Tender – cum – auction.

It is proposed to disposal and removal of following Garbage items available at the RCC, Trivandrum for a period of one year from 01.01.2018 to 31.12.2018, by Tender-cum-auction. The auction will be held at 3.00 pm on 18.11.2017.

1. Pet bottles
2. Vial cases
3. Base boards (paper)
4. Cydex Cans
5. Hypochlorite cans
6. Cartons
7. Ice Pack containers
8. Fused tubes and bulbs
9. Thermocol boxes
10. Plastic Wrappers

The participants are requested to note the following terms & conditions

1. The Tenders shall be submitted in sealed envelope superscribing “Tender for Disposal and removal of Garbage Items” and addressed to the Director, Regional Cancer Centre, Thiruvananthapuram-695011. The prescribed tender form shall invariably be used for this purpose.
2. The tender in sealed envelope and application to participate in the auction shall be received not later than 2 pm on 18.11.2017. Late tender / application will not be entertained.
3. To participate in the re-tender and auction an EMD of Rs.5000/- shall be remitted by DD drawn in favour of Director, Regional Cancer Centre,

Thiruvananthapuram, or RCC cash receipt. Tender without accompanying required EMD will be summarily rejected.

4. On conclusion of the auction procedures, the tender will be opened in presence of the tenderers as well as bidders. The successful bidder / auctioneer shall be required to remit 50% of the contract amount plus GST as applicable by 31.12.2017 before lifting of materials by Demand Draft in favour of Director, Regional Cancer Centre payable at Thiruvananthapuram.
5. The tenderer / auctioneer participating in the tender / auction shall be required to produce their identity proof to the satisfaction of the Director, Regional Cancer Centre, Thiruvananthapuram.
6. The Director, Regional Cancer Centre, Thiruvananthapuram reserves the right to admit or not to admit any person for participating in the tender / auction without sufficient identity proof produced.

TENDER CONDITIONS

1. Tender shall be accompanied by EMD in the form of DD drawn in favour of Director, Regional Cancer Centre, Thiruvananthapuram payable at Thiruvananthapuram or RCC cash receipt.
2. Tender / auction will be fixed in favour of the highest bidder subject to approval of Director. The successful bidder, shall remit 50% of the contract (s) amount plus applicable GST by 31-12-2017 & the balance amount including tax amount by 30-04-2018 and lift the materials at his own cost and risk on receipt of such order within the stipulated time.
3. The successful bidder shall enter into a contract with the Regional Cancer Centre as prescribed by RCC. The EMD of the defaulters will be forfeited.
4. The right to accept or deny any quotation / Tender, without assigning any reason thereof vested with the competent authority.
5. Tender-cum-auction proceedings are subject to approval of Director.
6. The EMD of the remaining tenderers/auctioneer will be refunded immediately after opening the tenders/completion of auction process.
7. The Regional Cancer Centre reserves the right to accept or reject any or all the tenders partially or wholly without assigning any reason thereof. The decision of the Director, Regional Cancer Centre in this regard shall not be opened to question and he/she shall not be bound to assign or disclose reasons for his/her decisions.
